Q1	В	Dean's List Reviewers work remotely to select the Dean's List Finalists	
Q2	В	Dean's List Reviewers select Finalists	
Q3	A, C, and D	Nomination essays and the interviewer notes are not written by the student, therefore they should not be evaluated for spelling, punctuation, or grammar.	
Q4	С	The finalists are only announced at the Regional Championship Tournament	
Q5	E	Finalist numbers are outlined in the Dean's List Nomination guide per region, and vary anywhere between 2-4 finalists per region	
Q6	В	Students are eligible to be nominated in both programs, as well as be a finalist for both programs	
Q7	Α	All finalists must be selected in the Judges Portal by 2/15/2026	
Q8	В	reviewers should not add any notes to the system. The notes section is solely for the interviewers to write about the student following the interview. The reviewers should follow the Dean's List award criteria when making finalist selections but should never enter more notes into the system.	
Q9	Α	Reviewers have access to sensitive information and must take this training prior to serving in this volunteer role.
